## Court Ordered Classes

To Whom it may concern:

Court Ordered Programs Inc. provides a Probation approved Batterer's Intervention Program and follows the approved Duluth Model standards through their In-Person school Court Ordered Classes. Our Mission is to stop domestic violence by teaching core skills, receive basic training in history, fundamental principles and concepts of partner abuse.

**Objectives of the Weekly BIP classes: The curriculum is designed to help men stop battering by achieving six objectives:**

1. To help the participant understand how his abuse stems from beliefs of entitlement which support his control of his partner's actions, thoughts, and feelings.
2. To increase the participants understanding of the causes of his examining the cultural and social contexts in which he uses violence against his partner.
3. To increase the participant's willingness to change his actions by examining the negative effects of his behavior on his relationship, his partner, his children, his friends, and himself.
4. To encourage the participant to become accountable to those he has hurt through his use of violence by helping him to acknowledge his abuse, accept responsibility for its impact on his partner and others, and take specific steps to change.
5. To increase the participant's understanding and willingness to change by exploring actions, intents, and beliefs that support equality with a woman.
6. To provide the opportunity for a man to find love, trust, and commitment in relationships with women and children by learning new ways of acting in a relationship.

To achieve the above objectives, the curriculum is organized around the ten themes found on the Equality Wheel and its corresponding Power and Control Wheel: Nonviolence; Nonthreatening Behavior; Respect; Trust and Support; Honesty and Accountability; Responsible Parenting; Shares Responsible; Economic Partnership; Sexual Respect; and Negotiation and Fairness.

Court Ordered Classes also provides Domestic Violence, Anger Management, Deferred Entry of Judgment, Drug/Alcohol Awareness, Criminal Behavior Modification, Parenting, Theft Prevention and Juvenile Betterment Programs.

These courses will help to learn to be responsible for behavior, fundamentals of controlling negative emotions and feelings, learning strategies and recognizing repetitive, antisocial behavioral patterns. Participants are expected to accept responsibility for behavior, participate in each session, be responsible for safety planning for the prevention of violence and be non-violent in relationships by utilizing the tools learned in order to maintain healthy relationships.

The efficacy of the treatment program will be established by measuring the progress of each client. The director will adhere to policy and procedure. The Program objective questionnaire will measure the outcome of Short-term objectives and Long Term Goals for clients.

**To establish the goals and objectives by which the Court Ordered Classes pursues its day to day operation. Court Ordered Programs implements the following policy of goals and objectives:**

To provide a safe, confidential, therapeutic and professional environment where clients can receive services which meets their needs. To consistently implement all appropriate Federal and State standards that apply. To provide group from appropriately licensed/certified staff. To utilize a clinical team of State licensed, certified professionals to evaluate and establish an individualized treatment plan for each client. To provide the highest quality treatment possible. To consistently apply performance improvement and outcome measures to ensure quality treatment is monitored and maintained. To assist clients in attaining healthy and productive lives free of the negative influences and consequences. To have clients improve their functioning level in their communities and with their families, and, to have clients will develop appropriate tools, support systems and continue interaction with these systems post discharge. It is hoped that the skills learned during this program will last a lifetime.
